## Definition of Small, Medium and Large is as follows

Small Fabricator:	0 to 2000 tonne per annum
Medium Fabricator:	2001 to 10000 tonne per annum
Large Fabricator:	Greater than 10000 tonne per annum

In the absence of tonnage data, the categories will be broadly based on the facility output. SCA decision is final

Tonnage estimate is based on data provided by the Fabricator and an assessment by the SCA regarding Facility Size, Equipment, Number of Employees either currently employed or could be reasonably utilized in the facility, for the type of work typically performed.

## Fees for a Second or Additional Facility belonging to The Company to be Certified

A discounted rate for Certification of a second or Additional Facility belonging to the Fabricator, may be applied, in recognition of the reduced amount of Auditing and Review Activities which may be needed.

Discounted rate for the Second or Additional Facility only applies if the Following Exists:

- a) Both Facilities have the same ownership structure.
- b) Both Facilities operate under the same Business and Quality Management Systems.
- c) There is commonality in terms of the Management Structure, i.e., the Management of the Second facility reports into Key Staff that formed part of the initial Certification Audit.
- d) There is commonality in terms of the various Business Functional Structures e.g.
  - i. The Business Quality Manager has ultimate responsibility for the quality function at both facilities.
  - ii. The Senior Business Welding Co-Ordinator/Welding Supervisor has ultimate responsibility for the welding function at both facilities.
- e) The documentation provided as part of the Application, the Stage 1 Audit and the Stage 2 Audit is the same (Apart from badging) and does not require different processes to be applied in the second facility compared with the Originally Certified Facility.
